

With several judgements concerning data protection, the European Court of Justice is a guardian of fundamental rights. It is therefore, a highly appropriate place to host this seminar.


The European draft regulation on Data protection aims to address the unprecedented challenges of the digital revolution. 
The same trend applies to the insurance sector. The large scale usage of data allows insurance companies to charge an insurance product under new criteria and to market new ranges of products.
